
A woman in her early 40s visits her dentist for a regular exam. There is no evident decay upon visual examination.

The CariVu image shows the exact location of the decay on tooth #19, minimizing the amount of tooth structure removed during treatment.





Transillumination Technology

Utilizing transillumination technology, DEXIS CariVu bathes the tooth in near-infrared light from the bottom up, making enamel appear transparent while porous lesions trap and absorb the light, helping clinicians to easily identify:

- Smooth surface caries
- Occlusal caries
- Proximal caries
- Initial caries
- Recurrent decay
- Cracks & fractures

CariVu also works great on braces, behind amalgams, around composites, and more.



Providing a structural view of a lesion, CariVu offers a precise and accurate snapshot of your patient's dental health. This can greatly aid in patient education efforts and may lead to greater patient acceptance of your proposed treatment plans.

CariVu Components

The CariVu tip comes in two sizes: small and large. The arms of the tip are flexible, allowing for a comfortable patient experience. Easily removed, the tips can be sterilized in autoclave for up to 250 cycles.



CariVu does not require a dry field or the clinician to clean the teeth prior to use and, as images are easy to read and understand, does not require the clinician to calibrate the device or become versed in the meaning of multiple color codes or numeric indicators.
